ADMINISTRATIVE ORDER NO. 031-2017

**FURTHER REORGANIZING AND RECONSTITUTING, THE
GENDER AND DEVELOPMENT (GAD) FOCAL POINT OF THE
SANDIGANBAYAN**

WHEREAS, on August 10, 2006, Administrative Order No. 110-2006 entitled "**CREATING A GENDER AND DEVELOPMENT (GAD) FOCAL POINT IN THE SANDIGANBAYAN**" formally constituted a GAD Focal Point in the Sandiganbayan;

WHEREAS, on September 1, 2006, the GAD Focal Point was reorganized and for such purpose, Administrative Order No. 110-2006 was amended by Administrative Order No. 118, 2006;

WHEREAS, on subsequent dates, Administrative Order Nos. 89-2007, 89-2008, 151-2008, 123-2009, 71-B-2010, 147-A-2011, 13-2012, 204-2014, 185-2013, 187-2013, 48-2014, 009-2015 and 264-2016 were issued covering the designations of various officials as Chairpersons and regular members of the GAD Focal Point in view of changes in the constitution of the Sandiganbayan GAD Focal Point;

WHEREAS, on August 12, 2016, the Philippine Commission on Women issued Memorandum Circular 2016-04 thereby requiring an updating of the GAD Focal Point System (GFPS) profile and database in the prescribed format;

NOW THEREFORE, the GAD Focal Point in the Sandiganbayan is hereby reorganized and reconstituted to be composed of the following:
