INVITATION TO BID FOR Procurement of Three (3) units 2016 SUV 2.4 liter diesel A/T

- The Sandiganbayan, through the <u>General Appropriations Act of 2016</u> intends to apply the sum of <u>Four Million Five Hundred Thousand Pesos (Php4.500.000.00) inclusive of Value Added Tax (12%).</u> being the Approved Budget for the Contract (ABC) to payments under the contract for <u>Procurement of Three (3) units 2016 SUV 4x2 2.4-liter diesel A/T.</u> Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Sandiganbayan Bids and Awards Committee (BAC), now invites bids for Procurement of Three (3) units 2016 SUV 4x2 2.4-liter diesel A/T. Delivery of the Goods is required within thirty (30) working days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 4. Interested bidders may obtain further information from **Sandiganbayan** and inspect the Bidding Documents at the address given below during office hours from <u>8:00 a.m. to 4:30 pm Monday to Friday from October 3, 2016 until 9:00 a.m. of October 25, 2016.</u>

A complete set of Bidding Documents may be purchased by interested Bidders on <u>October 3, 2016, from 9:00 a.m. to 4:00 p.m until 9:00 am of October 19, 2016</u> from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of <u>Five Thousand Pesos (Php5,000.00)</u>.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

- 5. The BAC will hold a **Pre-Bid Conference** on <u>October 11, 2016, Office of Executive Clerk of Court IV</u> <u>Conference Room, Ground Flr., Sandiganbayan, Commonwealth Ave., Quezon City at 10:00 a.m., which shall be open only to all interested parties who have purchased the Bidding Documents.</u>
- 6. Bids must be delivered to the address below on or before October 25, 2016 at 9:30 a.m. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
 - Bid opening shall be on <u>October 25. 2016 at 10:00 a.m.</u> at the <u>Office of Executive Clerk of Court IV</u> <u>Conference Room. Ground Flr.. Sandiganbayan. Commonwealth Ave.. Quezon City</u>. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 7. The bidder shall submit two (2) copies of their duly accomplished eligibility and technical requirements, and the financial component of the bid in two separate sealed envelopes at the address given written below.
- 8. The **Sandiganbayan Bids and Awards Committee (BAC)** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
