Lala, Marlina S. Alvizo, Pureza A. Fernandez, Cresencio T. Bagolor, Buenaventurada C. Pajo, Augustinito P. Hermoso and Luis A. Galang, together with the prosecution's Comment/Opposition (To the Motion for Comparison, Stipulation and Remarking of Exhibits dated 21 May 2018 of accused Lala, Alvizo, Fernandez, Bagolor, Pajo, Hermoso and Galang), this Court resolves as follows:

- 1. Said accused' Reply to Comment/Opposition<sup>3</sup> is NOTED.
- 2. As prayed for, let Exhibit 77 be re-marked as Exhibit 226; Exhibit C be marked as Exhibit 227; and the provisional marking of Exhibit 225 be removed and the same be re-marked as Exhibit 225.

  - b. Exhibit 6 with Exhibit 67;
  - c. Exhibit 71 with Exhibit T; and
  - d. Exhibit 8 with Exhibit 212.
