The following resolution was adopted:

**SB-17-CRM-0648 and 0649 –**

**PEOPLE vs. ENRICO R. ECHIVERRI, ET AL.**

In the higher interest of substantial justice, and considering the additional exhibits and witnesses sought to be included in the pre-trial order, the Court resolves to **GRANT** the prosecution's *Motion to Admit Attached Final Pre-trial Brief<sup>1</sup>* over the objection of the accused.<sup>2</sup> The prosecution's *Final Pre-trial Brief<sup>3</sup>* is hereby **ADMITTED**.


