FERNANDEZ, SJ, J.

Acting on the information provided by Special Investigator III Roel M. Jovenir, Technical Intelligence Division, Intelligence Service of the National Bureau of Investigation, in the *Return of Service of Warrant of Arrest*¹ that accused Francisco Aldana Calalay, Jr. had passed away on December 19, 2016, this Court directed the prosecution to confirm the alleged death of accused Calalay.²

On September 18, 2018, the prosecution filed its *Compliance*,³ together with a copy of the Certificate of Death with Registry No. 2016-22566 issued by the Philippine Statistics Authority.

Certificate of Death with Registry No. 2016-22566 shows that one **FRANCISCO ALDANA CALALAY, JR.** passed away on December 19, 2016.

The Court finds that the death of accused Francisco Aldana Calalay, Jr. was sufficiently established.

WHEREFORE, pursuant to Article 89 of the Revised Penal Code, the cases against accused Francisco Aldana Calalay, Jr. are **DISMISSED**.

The Hold Departure Order dated April 30, 2018 issued against accused Calalay is hereby **LIFTED**.


