
- a) Certificate of Death with Registry No. 2014-302 issued by the Philippine Statistics Authority (PSA), showing that one **NORIE KAMAONG UNAS** passed away on April 14, 2014;
- b) Certificate of Death with Registry No. 2016-681 issued by the PSA, showing that one **LANDAP PIGCAULAN GUINAID** passed away on July 28, 2016; and,
- c) Certificate of Death with Registry No. 2016-05 issued by the PSA, showing that one **KASAN INDONG MACAPENDEG** passed away on December 13, 2015.

It appears from the foregoing that the death of accused Unas, Guinaid and Macapendeg were sufficiently established.

WHEREFORE, pursuant to Article 89 of the Revised Penal Code, the instant cases against accused Norie Kamaong Unas, Landap Pigcaulan Guinaid, and, Kasan Indong Macapendeg, are hereby **DISMISSED**.


The prosecution's *Manifestation with Motion for Extension* filed on October 1, 2018 is **NOTED**.
