The following resolution was adopted:

Crim. Case SB-13-CRM-0907 **PEOPLE vs. HARRY C. ANGPING,
ET AL.**

This resolves the *Motion to Release Cash Bail Bond and Travel Bond*¹ filed by Harry Cosiquien Angping on December 13, 2018.

During the hearing on the *Motion* held on December 17, 2018, Prosecutor Jennifer A. Agustin-Se, interposed no objection.²

The *Motion to Release Cash Bail Bond and Travel Bond* filed by Harry Cosiquien Angping is **GRANTED**.

Section 22, Rule 114 of the Revised Rules of Criminal Procedure provides that bail shall be deemed automatically cancelled upon acquittal of the accused.

In view of the *Decision*³ dated December 3, 2018, which acquitted Harry Cosiquien Angping of the charge of violation of Section 3(e) of RA 3019, the Court in its December 3, 2018 *Order*⁴ directed the cancellation and release of the bail bond of Harry Cosiquien Angping upon presentation of official receipts, subject to compliance with the usual accounting and auditing procedures.

The Court reiterates its December 03, 2018 *Order*. The Court, pursuant to Section 22, Rule 114 of the Revised Rules of Criminal Procedure, hereby orders the release, subject to the usual accounting and auditing procedure, of the following:

1. The Cash Bail Bond posted by Harry Cosiquien Angping on September 19, 2013 in the amount of Thirty Thousand Pesos
