RESOLUTION

QUIROZ, J.:

On April 29, 2019, accused Amelita S. Navarro and Martha A. Pascual filed a *Manifestation and Omnibus Motion (Re: a) To re-mark accused' documentary exhibits; b) Transfer of markings of accused' documentary exhibits; c) To adopt some of the prosecution's exhibits).*¹ In said motion, both accused pray, among others, to adopt the following documentary exhibits of the prosecution: Exhibit "H-1" – Trust Trade Delivery Receipt No. 18234 dated January 8, 2010 as their Exhibit "9;" Exhibit "I" – Firearm License Cards-Juridical as their Exhibit "10;" Exhibit "I-1" – Firearm License Cards-juridical as their Exhibit "10-A;" and Exhibit "J" – Permit to Transport Firearms issued to Local Government Unit Santiago City as their Exhibit "11."

As observed by the prosecution in its *Manifestation with Motion*² dated May 8, 2019, the adoption of its Exhibits "H-1," "I," "I-1," and "J" as Exhibits "9," "10," "10-A," and "11" of both accused might cause confusion since there are already evidence previously marked for the defense in the Pre-Trial Order³ dated July 11, 2018 as follows:


"9"	Letter dated December 9, 2010 addressed to Hon. Reynaldo A. Villar, Chairman of the COA signed by Amelita S. Navarro	Due execution and existence admitted by the defense
"10"	Liquidation Report December 9, 2010 regarding the liquidation of Cash Advance of Intelligence/Confidential Fund amounting to Php15,000,000.00	Due execution and existence admitted by the defense
"11"	Credit Notice dated December 28, 2010 issued by the COA and signed by Nilda B. Plasas by authority of the Chairman	Due execution and existence admitted by the defense

WHEREFORE, accused Amelita S. Navarro and Martha A. Pascual are **DIRECTED** to clarify to the Court within five (5) days from notice hereof whether the Exhibits "9," "10," and "11" listed in the Pre-Trial Order dated July 11, 2018 will be deleted and replaced by the Exhibits "9," "10," "10-A," and "11" mentioned in their *Manifestation and Omnibus Motion*.
