- 1. No bids shall be accepted earlier than December 14, 2021. Late submission of bids shall likewise not be accepted.
- 2. No bid shall be lower than the posted minimum/floor price.
- 3. A bidder can bid for one or more lots.
- 4. Bidders must present a NEGATIVE antigen/PCR test medical clearance taken within the last forty-eight (48) hours prior to the scheduled bidding activities.
- 5. The sealed bid shall be accompanied by a refundable bidder's cash bond in the amount equivalent to at least ten percent (10%) of the total bid price. The bond shall be considered as partial payment for the offer and the difference in the amount between the offer and the bond shall be paid within five (5) working days from the date of receipt of the Notice of Award. In case of refusal to accept the award or enter into contract with the Sandiganbayan, the bond shall be forfeited.

6. The Sandiganbayan reserves the right to reject any or all bids, or part thereof, waives any formality, requirements or defects contained therein or will accept the offer it considers most advantageous to the government. The decision of the Sandiganbayan is final and binding.

## SUB-COMMITTEE ON DISPOSAL OF EQUIPMENT, VEHICLE, AND FURNITURE

#### TERMS AND CONDITIONS

- 1. The bidding will be conducted in accordance with Office Order No. 234-2019 pertaining to the *Guidelines on the Purchase and Disposal of Official Motor Vehicles of the Presiding justice*, Associate Justices, Other Court Officials and the Support Services issued by the Sandiganbayan on September 18, 2019.
- 2. The bidding shall be open to the public except for members of the Sub-Committee on Disposal of Equipment, Vehicles and Furniture and their relatives within the third civil degree of consanguinity or affinity.
- 3. A bidder can bid for one or more lots. The sealed bids shall be accompanied by a refundable bidder's cash bond.
- 4. The sealed bids shall be for all the items described in the notice of Public Auction on an "AS IS, WHERE IS" and "CASH and CARRY" basis.
- 5. Sealed bids for each lot must **not be lower than the minimum bid prices** as indicated in the Notice of Public Auction.
- 6. Sealed bids must be accompanied by **bidder's cash bond**, likewise sealed, equivalent to **ten percent (10%)** of the total bid price. The cash bond of the winning bidder/s will be forfeited in favor of the government as liquidated damages upon failure to pay the approved bid prices within five (5) calendar days after formal notice of award. The bidder's bond of the first three (3) highest bidders will be retained until the sale is consummated.
- 7. The Sub-Committee on Disposal of Equipment, Vehicles, and Furniture shall open all the submitted sealed bids in the presence of participating bidders and the COA Auditor or her representative at the date and time stated in the Notice of Public Auction.

The Sub-Committee on Disposal of Equipment, Vehicles, and Furniture shall thereafter submit its report and recommendation to the Presiding Justice for approval.

8. The winning bidder shall, after paying the approved bid price/s with the Court's Cashier, remove/haul the subject motor vehicles from the Court premises within fifteen (15) calendar days from the issuance of the Notice of Award and shall shoulder all expenses relative thereto.
