



Invitation to Apply for Eligibility and to Bid Comprehensive Health Care Package for the Sandiganbayan (2018-2019)

The Sandiganbayan, through its Savings as authorized by the Hon. Chief Justice of the Supreme Court per Augmentation Realignment Order (ARO) No. 2013-001 (Calendar Year 2018), intends to apply the sum of **Twenty Two Million Pesos** (PhP 22,000,000.00) only, inclusive of **12% Value Added Tax**, being the Approved Budget for the Contract (ABC), to payments under the contract for the **Comprehensive Health Care Package for the Sandiganbayan (CY 2018-2019)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The Sandiganbayan Bids and Awards Committee (BAC) invites bids for the “**Comprehensive Health Care Package for the Sandiganbayan (2018-2019)**”, described as follows:

2. The Delivery of the Goods is required on **May 16, 2018 for a duration of one (1) year**. Bidders should have completed, **within five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders (ITB).

Interested bidders may obtain the Bid Documents starting on February 27, 2018 until the date of the bid opening and upon payment of a non-refundable amount of **TWENTY THOUSAND PESOS (P20,000.00)**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted.

Interested bidders may obtain additional information and/or inspect the Bidding Documents at the address given below from Monday to Friday, 8:00 a.m. to 4:30 p.m. The Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the Sandiganbayan website provided that Bidders shall pay the non-refundable bid fee for the Bidding Documents not later than the submission of their bids.

5. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

6. The Pre-Bid Conference is open to all interested persons.
7. The Sandiganbayan reserves the right to accept or reject any bid, declare a failure of bidding, or reject all bids at any time prior to contract award in accordance with Section 41 of RA 9184 and its RIRR, without thereby incurring any liability to the affected bidder or bidders.
