- 1. The Sandiganbayan, through the <u>General Appropriations MOOE 2016</u>, intends to apply the sum of <u>Php2,474,160.00</u> (<u>Two Million Four Hundred Seventy Four Thousand One Hundred Sixty Pesos) inclusive of Value Added Tax (12%)</u>, being the Approved Budget for the Contract (ABC) covering one (1) year only to payments under the contract for the <u>PROCUREMENT OF SERVICES FOR FIVE (5) SECURITY PERSONNEL FOR SANDIGANBAYAN (For three (3) years)</u>. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Sandiganbayan Bids and Awards Committee (BAC) now invites bids for the **Procurement of Services for Five (5) Security Personnel for Sandiganbayan (for three (3) years).** Bidders should have completed, within five (5) years from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 4. Interested bidders may obtain further information from Sandiganbayan and inspect the Bidding Documents at the address given below during office hour from 8:00 a.m. to 4:30 pm Monday to Friday from June 28, 2016 until 9:00 a.m. of July 20, 2016.
- 5. A complete set of Bidding Documents may be purchased by interested Bidders on <u>June 28</u>, <u>2016</u>, <u>from 9:00 a.m. to 4:00 p.m until 9:00 am of July 20, 2016</u> from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of <u>Five</u> Thousand Pesos (Php 5,000.00).

- 6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
- 7. The Sandiganbayan Bids and Awards Committee (BAC) will hold a Pre-Bid Conference on <u>July 6, 2016</u>, <u>Office of Executive Clerk of Court IV Conference Room, Ground Flr., Sandiganbayan Commonwealth Ave., Quezon City at 10:00 a.m.</u>, which shall be open only to all interested parties who have purchased the Bidding Documents.
- 8. Bids must be delivered to the address below on or before <u>July 20, 2016 at 9:30 a.m.</u> All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
- 9. Bid opening shall be on <u>July 20, 2016 at 10:00 a.m.</u> at <u>Office of Executive Clerk of Court IV Conference Room, Ground Flr., Sandiganbayan Commonwealth Ave., Quezon City</u>. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 10. The Sandiganbayan Bids and Awards Committee (BAC) reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
