- The Sandiganbayan, through the <u>General Appropriation Act 2016</u> intends to apply the sum of <u>One Million Five Hundred Sixty Thousand Eight Hundred Seventy Eight Pesos and 2/100 (Php 1,560,878.02) inclusive of Value Added Tax (12%), being the Approved Budget for the Contract (ABC) to payments under the contract for <u>Procurement of IP Digital CCTV System</u>. Bids received in excess of the ABC shall be automatically rejected at bid opening.</u>
- The Sandiganbayan Bids and Awards Committee (BAC), now invites bids for <u>Procurement of IP Digital CCTV System</u>. Delivery of the Goods is required within <u>thirty (30) calendar days</u> from receipt of Notice to Proceed. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 4. Interested bidders may obtain further information from Sandiganbayan and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 4:30 pm Monday to Friday from October 5, 2016 until 9:00 a.m. of October 26, 2016. A complete set of Bidding Documents may be purchased by interested Bidders on October 5, 2016, from 9:00 a.m. to 4:00 p.m until 9:00 am of October 26, 2016 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five Thousand Pesos (Php 5,000.00). It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
- The Sandiganbayan Bids and Awards Committee (BAC)will hold a Pre-Bid Conference on October 12, 2016, Office of Executive Clerk of Court IV Conference Room, Ground Flr., Sandiganbayan Commonwealth Ave., Quezon City at 10:00 a.m., which shall beopen only to all interested parties who have purchased the Bidding Documents.
- 6. Bids must be delivered to the address below on or before October 26, 2016 at 9:30 a.m. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause. Bid opening shall be on October 26, 2016 at 10:00 a.m. at Office of Executive Clerk of Court IV Conference Room, Ground Flr., Sandiganbayan Commonwealth Ave., Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 7. The bidder shall submit two (2) copies of their duly accomplished eligibility and technical requirements, financial component of the bid in two separate sealed envelopes at the address given written below.
- 8. The Sandiganbayan Bids and Awards Committee (BAC) reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
