- The Supplier shall also provide at least one (1) storage container, including ice gel packs, that can sustain cold temperature required for the vaccines.

Waste Disposal:

Supplier must be responsible for the proper collection and disposal of waste materials used

Warranty Terms:

The Supplier shall provide replacement of all vaccines found to have damaged or broken packaging prior to the acceptance of the Sandiganbayan.

Other Requirements:

- Copy of valid, current License to Operate from FDA and/or DOH Accreditation as Supplier, Distributor or Manufacturer for Drugs and Medicines;
- Copy of current and valid Certificate of Product Registration (CPR);
- Batch or Lot Release Certificate issued by the Bureau of Food and Drugs (BFAD/FDA) in accordance with DOH AO No. 47-as.2001.
