Sir/madam:

Please quote your lowest prices to the Government on the following items:

One (1) lot Preventive Maintenance of Water Station for P _____ /lot
One (1) year with the following Scope of Work:

- a. Monthly regular check-up of equipment;
- b. Monthly water quality monitoring such as TDS, hardness and pH;
- c. Monthly equipment calibration;
- d. Consultation and recommendation;
- e. Monthly regeneration of water softener;
- f. Change filters, if needed;
- g. Backwashing of multimedia
- h. Monthly bacteriological test for total coliform, fecal coliform and heterotrophic plate count;
- i. Annual refill of resins/media filter;
- j. Annual refill/cleaning of membrane and provide service unit thereof;
- k. Quarterly cleaning of membrane or as needed; and
- l. Annual replacement of UV lamp

3. This Office hereby reserves the right to reject any or all offers, or accept such offer it may consider most economical and advantageous to the government.

That the dealer should specify below, the duration of the time they can hold the items available for this agency, and the penalty of failure to deliver within the period stipulated for reasons of non-availability of stock, contrary to the guaranty of its availability contained in the quotations submitted, will be the payment of the difference of the amount paid by this agency to the dealer quoting the next lower price, and that offered by the delinquent dealer.

5. That the Official Invoice/Official Receipt of dealer contains his/her firm's Tax Account No. and BIR Permit No. pursuant to P.D. 1255, as amended.


