MINUTES of the Proceedings held on September 1, 2022

The following resolution was adopted in the following cases:

**Crim. Cases No. SB-22-CRM-0074 to 0093 – PEOPLE VS. JERRY ERMIO PACTURAN, ET AL.**

In its *Resolution* dated July 5, 2022, the Court, after receiving the separate *Returns of Warrant of Arrest* filed by Clenio B. Calleja, Investigation Agent III of the National Bureau of Investigation (NBI),<sup>1</sup> and PLTCOL Victor M. Sobrepena of the Philippine National Police – Criminal Investigation and Detection Group (PNP-CIDG)<sup>2</sup> reporting the non-service of the *Warrant of Arrest* dated May 17, 2022, against accused Eulogio D. Rodriguez, because said accused passed away on July 22, 2021, directed the prosecution to confirm, through a certificate of death authenticated by the Philippine Statistics Authority (PSA), the alleged death of accused Rodriguez.

In its *Compliance (To the Resolution dated July 5, 2022)*,<sup>3</sup> the prosecution attached the PSA's *Compliance* dated August 8, 2022 together with a copy of a PSA-issued *Certificate of Death* with Registry No. 2021-1772 of a certain Eulogio Dimailig Rodriguez, born on September 27, 1953 and who died on July 22, 2021 in Sta. Rosa, Laguna.

In view thereof, it appears that the death of accused EULOGIO D. RODRIGUEZ has been sufficiently established.

**WHEREFORE**, pursuant to Article 89 of the *Revised Penal Code*, the cases against accused EULOGIO D. RODRIGUEZ is hereby ordered **DISMISSED**, without prejudice to the filing of a separate civil case against his estate, should circumstances warrant. The *Hold Departure Order* dated May 17, 2022 issued against Eulogio D. Rodriguez is **LIFTED**. Furnish the Bureau of Immigration with a copy of this *Resolution*
