The following resolution was adopted:

Crim. Case No. SB-16-CRM-1276 to 1285 - People vs. CRISPINA VEGA SALUMBRE

This resolves the following:

1. Final Report concerning Crispina V. Salumbre dated November 14, 2023 by SPPO Jesus L. Balgua, attached to the letter of CPPO Ma. Jessica C. Aquino of the Pasig City PPO, all electronically filed on November 16, 2023.¹

TRESPESES, J.

Accused Crispina Vega Salumbre's Application for Probation was approved by the court in the Minute Resolution dated 8 November 2021, following a favorable recommendation in the Post Sentence Investigation Report of Supervising Probation and Parole Officer George P. Perez. Thereafter, accused was placed on probation for two years.

On 16 November 2023, the court received a copy of the Final Report prepared Jesusa L. Balgua, Supervising Probation and Parole Officer, and approved by Ma. Jessica C. Aquino, Chief Probation and Parole Officer of the Pasig City Parole and Probation Office, informing that accused Salumbre substantially complied with the terms and conditions of her probation. Consequently, they recommended that accused Salumbre's probation be terminated.

Acting on said recommendation and upon evaluation of the Final Report, it is clear that the purpose of probation has been duly served. In view thereof, the probation of accused **Crispina Vega Salumbre** is hereby **TERMINATED**. Accused Salumbre is thus **DISCHARGED** and, pursuant

to Section 16 of Presidential Decree No. 968, as amended, she is restored to all the civil rights that she lost because of her conviction.

Further, the cash bond posted by accused Salumbre for her provisional liberty is ordered **RELEASED** to her or her duly authorized representative subject to the usual accounting rules and procedure. The Hold Departure Order dated December 13, 2016 including Ms. Salumbre's name in the Hold Departure List of the Bureau of Immigration is **RECALLED** and **CANCELLED**.
