"B.M. No. 3978 (In Re: 2023 Bar Examinations). — Considering the recommendations of Associate Justice Ramon Paul L. Hernando, Chairperson, 2023 Bar Examinations, requesting the implementation of measures aimed to ensure the uninterrupted completion by Judiciary employees of their tasks during the period of their deployment to the Bar Examination sites as Bar personnel and in order to align with the three-week Intensive Decision Writing Break scheduled in September 2023, the Court resolved to:
