**DECLARING FAILURE OF BIDDING AND RECOMMENDING A REBIDDING OF  
"One (1) unit 2017 model Ambulance Van with Complete Life Support Equipment"**

**WHEREAS**, on August 10, 2017, an Invitation to Bid was published by the Sandiganbayan Bids and Awards Committee (BAC) for the "Procurement of One (1) unit model Ambulance Van with Complete Life Support Equipment" for the Sandiganbayan in the amount of One Million Eight Hundred Thousand (Php1,800,000.00) Only inclusive of 12% Value Added Tax (VAT);

**WHEREAS**, a Pre-Bid Conference was scheduled on August 17, 2017, 2:00p.m. at the Administrative Conference Room, Ground Floor of the Sandiganbayan Centennial Building, Quezon City. However, no prospective bidder attended the said Conference;


**WHEREAS**, on September 4, 2017, the Bid Opening for the intended procurement was scheduled. However, no bidder purchased the bidding documents nor submitted any letter of intent to bid;

**WHEREAS**, the BAC agreed to remove certain medical equipment from the list of its technical specifications in order to invite participation of prospective bidders in the second round of bidding of the intended procurement;


**NOW, THEREFORE**, in view of the foregoing, it is hereby **RESOLVED**, as it hereby **RESOLVES** by the Members of the **SANDIGANBAYAN BIDS AND AWARDS COMMITTEE**, to declare a **FAILURE OF BIDDING** under Section 35.1(a) of R.A. 9184<sup>1</sup> AND **RECOMMENDING A REBIDDING** of the **PROCUREMENT OF ONE (1) UNIT 2017 MODEL AMBULANCE VAN WITH COMPLETE LIFE SUPPORT EQUIPMENT FOR THE SANDIGANBAYAN**




