INVITATION TO BID
***One (1) Lot Provision of Comprehensive Healthcare Package
for the Sandiganbayan for One Year (2021-2022)***
(Reference No. SB-BID01-2021)

1. The Sandiganbayan, through its Continuing Appropriations, intends to apply the sum of **Twenty Six Million Pesos (Php 26,000,000.00) Only, inclusive of 12% Value Added Tax (VAT), being the Approved Budget for the Contract (ABC)** to payment under the contract for ***One (1) LOT Provision of Comprehensive Healthcare Package for the Sandiganbayan for One Year (2021-2022) with Reference No. SB-BID06-2020.*** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Sandiganbayan now invites bids for the above Procurement Project. Commencement of the provision of services shall be on May 16, 2021. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the Sandiganbayan and inspect the Bidding Documents at the address given below from 8:00 A.M to 4:00 P.M.

9. Bid opening shall be on **March 26, 2021, 2:00 P.M.** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The *Sandiganbayan* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 Revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
