**INVITATION TO BID**  
***One (1) LOT***  
***Provision of Third-Party Security***  
***Personnel and K-9 Team for the***  
***Sandiganbayan for One (1) Year (2022-2023)***  
***(Reference No. SB-BID02-2022)***

1. The Sandiganbayan, through the General Appropriations Act of 2022, intends to apply the sum of **Six Million Pesos (Php 6,000,000.00) Only, inclusive of 12% Value Added Tax (VAT), being the Approved Budget for the Contract (ABC)** for the payment of the contract for ***One (1) LOT Provision Third-Party Security Personnel and K-9 Team for the Sandiganbayan for One (1) Year (2022-2023) with Reference No. SB-BID02-2022.*** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Sandiganbayan now invites bids for the above Procurement Project. **Commencement of the services shall be fifteen (15) days after the receipt by winning bidder of the Notice to Proceed (NTP).** Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the Sandiganbayan and inspect the Bidding Documents at the address given below from 9:00 A.M to 4:00 P.M.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **January 21, 2022** at the Legal Research and Technical Staff, 2/F, Sandiganbayan Centennial Building, Batasan Road, Quezon City, or at <https://sb.judiciary.gov.ph/> and upon payment of the applicable fee of **Five Thousand Pesos (PhP5,000.00)** , pursuant to the latest Guidelines issued by the GPPB. The Procuring Entity shall allow the bidder to present its proof of payment for the fees either through personal, facsimile, or electronic means.
6. The Sandiganbayan will hold a **Pre-Bid Conference on January 31, 2022,<sup>1</sup> 10:00 A.M.** which shall be open to all prospective bidders through the zoom videoconference platform, with details as follows:

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **February 14, 2022, 9:30 A.M.**  
Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **February 14, 2022, 10:00 A.M.** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *Sandiganbayan* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 Revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
11. **All bidders and/or their duly authorized representatives must present a NEGATIVE antigen/PCR test medical clearance taken within the last forty-eight (48) hours prior to the scheduled bidding activities. Only one (1) representative of the bidder will be allowed entry into the Sandiganbayan Centennial Building.**
