**Invitation to Apply for Eligibility and to Bid**

**Procurement of Supply and Installation of Brand New Air-conditioning Units for the Sandiganbayan**

The Sandiganbayan, through its General Appropriations Act of 2018, intends to apply the sum of **Twenty-two Million Seven Hundred Fifty Thousand Pesos (PhP 22,750,000.00) only, inclusive of 12% Value Added Tax**, being the **Approved Budget for the Contract (ABC)** for the following project:

1. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, contract/s similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders (ITB).

Interested bidders may obtain the Bid Documents starting on **February 13, 2019** until the date of the bid opening and upon payment of a non-refundable amount of **Fifteen Thousand Pesos (P15,000.00)**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. **Late bids shall not be accepted.**

Interested bidders may obtain additional information and/or inspect the Bidding Documents at the address given below from Monday to Friday, 8:00 a.m. to 4:00 p.m.


The Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the Sandiganbayan website provided that Bidders shall pay the non-refundable bid fee for the Bidding Documents not later than the submission of their bids.

5. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to R.A. No. 5183 and subject to Commonwealth Act No.138.

6. The Pre-Bid Conference is open to all interested persons.
7. The Sandiganbayan reserves the right to accept or reject any bid, declare a failure of bidding, or reject all bids at any time prior to contract award in accordance with Section 41 of R.A. No. 9184 and its 2016 RIRR, without thereby incurring any liability to the affected bidder or bidders.
