## INVITATION TO BID FOR

## Procurement of Ninety Eight (98) units Assorted Cabinet

- 1. The Sandiganbayan, through the <u>General Appropriation 2016</u> intends to apply the sum of <u>Nine Hundred Twenty Eight Thousand Eight Peso only (Php 928,080.00)</u> inclusive of Value Added Tax of (12%), being the Approved Budget for the Contract (ABC) to payments under the contract for <u>Procurement of Ninety Eight (98) units Assorted Cabinet</u>. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Sandiganbayan Bids and Awards Committee (BAC), now invites bids for Procurement of Ninety Eight (98) units Assorted Cabinet. Delivery of the Goods is required Thirty (30) calendar days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 4. Interested bidders may obtain further information from Sandiganbayan and inspect the Bidding Documents at the address given below during office hour from 8:00 a.m. to 4:30 pm Monday to Friday from June 27 until 9:00 a.m. of July 19, 2016.
- 5. A complete set of Bidding Documents may be purchased by interested Bidders on <u>June</u> 27, 2016, from 9:00 a.m. to 4:00 p.m until 9:00 am of July 19, 2016 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of <u>One Thousand Pesos (Php 1,000.00)</u>.
- 6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
